As such, GIC has the sole power to vote and power to dispose of the 12,955,224 securities beneficially owned by it. GIC shares power to vote and dispose of 3,562,541 securities beneficially owned by it with MAS.
  - GIC is wholly-owned by the GoS and was set up with the sole purpose of managing Singapore's foreign reserves. The GoS disclaims beneficial ownership of such shares.
